III. TREASURER REPORT

- a. Fiscal Review
 - i. Increased income by working hard to collect dues from 170 homes, 18 over average

- ii. Decreased the following expenses accounting (doing our mailings and switching to Quickbooks online), landscaping (contract with new company, neighborhood clean up days)
- iii. Future possible expenses New pond liner, Replace pathway into Fairview Commons off of Olde Franklin, Clean-up in inner commons
- b. Overview of expenses for 2025 see attached OFT Profit & Loss 2025 Review sheet
 - i. Proposed dues increase to \$400, increase late fee to \$50
 - 1. 170 households x \$400 = \$68,00 which will give us the funds to pay for above additional expenses
 - ii. Q&A about budget
 - 1. When is the late fee assessed? 90 days (March 1st)
 - 2. What is the difference between dues and special assessment? dues are for operating expenses, special assessments are a one time charge for a specific unplanned issue
 - 3. We'll work with homeowners on a case by case basis to assist with dues payments installments, reduce late fees etc
 - 4. Can we get a balance sheet as well as profit and loss statement with the budget in the future?
 - 5. We should only increase the dues if they aren't covering regular expenses
