Check Out the Board Tasks

August 2025

- Held the first ever Block Party with at least 100 neighbors in attendance!
- Researched aeration systems for the water wheel pond and obtained quotes
- Met with Tim from Ace Outdoor Services to check-in and ensure high-quality maintenance of grounds and landscaping
- Held a subdivision-wide garage sale

September 2025

- Jason installed an aeration system in the water wheel pond to aid in reducing the muck and improve visual appeal
- Held the second Fireside Q & A, to give updates and neighbors a chance to ask questions
- Continued to treat the pond with wildlife-safe chemicals to reduce the amount of muck
- · Finance Committee met to review current financial status and discuss budget and future projects

October 2025

HOA Treasurer Report



Financial Overview

• February 15th Account Balance: \$49,288

• An additional \$11,766.58 came in after the February dues deadline!



Average Expenses Over Five Years

- Average expenses over the past 5 years: \$60,284.97
- Febraury Account Balance: \$49,288
- Special Assessment (\$8,250) = \$57,538
- The Finance Committee was concerned we would not have enough to cover all 2025 expenses without utilizing 2026 dues collected in November

Efforts Made to Reduce Costs in 2025

- Rachel and Jason took over all mailings (Saved \$1,300)
- New contract with ACE Landscaping started \$3,000 lower than the base contract with Troy Clogg
- Neighborhood Clean-Up days
- Obtained multiple quotes for various grounds issues
- Monitoried expenses carefully throughout the year
- Made sure expenses did not exceed \$61,054

Proposed Dues Increase For 2026

- Board voted to increase the late fee to \$50
- Proposing a dues increase to:
 \$400 annually for dues
- 170 households x \$400 = \$68,000
- \$7,700 buffer to put towards grounds maintenance, pond and water wheel maintenance, special grounds projects, and tree removal when needed etc.



Communication: Organized two Fireside Q&A sessions and posted the first ever Neighborhood Update video.

Pond Improvements: Installed the Pond Aeration System. Continuing to work on clearing out invasive plants from the pond. Constructed/installed a new bench at the pond. Assisted with the construction of the new water wheel.

Grounds: Cleared out dead/felled trees from the trails and common areas.

Future Goals: Continue to bring the neighborhood community together through increasing/improving our communications. Continue to host events that foster community-building. Continue to maintain the water wheel aeration system to further beautify the pond.

Committees: Finance, Communications, Playground/Community Space


Resident of OFT for 10 years. Married with three boys. Engaged community leader.

Future Goals: Continue fostering transparent communication between Board Members and residents of OFT. Establish processes for committees. Maintain strong community engagement.




Ted Bishop


Trails: Assisted with implementing a successful Trails Clean-Up Day, aiding in the safety and walkability of our beautiful trails around OFT.
